You will be asked to participate in an interview that would take approximately 1 hour. During the interview a member of the research team will ask you questions about the organisations processes for energy procurement, drivers in energy procurement, attitudes towards and experience with renewable energy procurement, and details of any off-site renewable energy procurement experience your organisation has had. With your permission we would like to digitially record the interview using an audio recorder. The interviews will take place in a location to be negotiated which is suitable for both parties.

Will I be paid to participate in this project?

There are no costs associated with participating in this research study, nor will you be paid.

What are the possible benefits to participation?

We hope to use information we get from this research study to enable the development of efficient bilateral procurement of off-site renewable energy in Australia.

What will happen to information about me?

By signing the consent form you consent to the research team collecting and using information about you for the research study. We will keep your data for a period of 7 years. We will store information about you in a secure shared project drive on the UNSW File Server. Your information will only be used for the purpose of this research study and it will only be disclosed with your permission.

It is anticipated that the results of this research study will be published and/or presented in a variety of forums. In any publication and/or presentation, information will be published, in a way such that you will not be individually identifiable. Although every effort will be made to protect your identity, there is a risk that you might be identifiable in publications due to the nature of the study and/or the results.

You have the right to request access to the information about you that is collected and stored by the research team. You also have the right to request that any information with which you disagree be corrected. You can do this by contacting a member of the research team.

The audiotaped digital recordings are for the purposes of the research study. After the interview we will transcribe and then delete your digital recordings.

How and when will I find out what the results of the research study are?

You have a right to receive feedback about the overall results of this study. You may receive feedback regarding the research by attending the workshops to be held during the project or via the project website.

You will receive this feedback after the study is finished.

What if I want to withdraw from the research study?

If you do consent to participate, you may withdraw at any time. If you do withdraw, you will be asked to complete and sign the 'Withdrawal of Consent Form' which is provided at the end of this document. Alternatively you can ring the research team and tell them you no longer want to participate.

If you decide to leave the research study, the researchers will not collect additional information from you.

You are free to stop the interview at any time. Unless you say that you want us to keep them, any recordings will be erased and the information you have provided will not be included in the study
